1. ACCEPTANCE OF TERMS

Such modifications and additional terms and conditions will be effective immediately and incorporated into this Agreement. Your continued use of the Allison Publications Service will be deemed acceptance thereof.

4. SCOPE OF LICENSE

This license granted to you by Allison for the relevant Allison Publications Products is limited to a personal, non-exclusive, non-transferable, non-sublicensable, terminable license to use the Allison Publications Products as permitted by this Agreement.
